## B. APPROVAL OF AGENDA

## E. PRESENTATION FROM CSP (Manchester Stamping) on EXPANSION PLAN

Enos- This is a relatively simple site plan. The ordinance says if adding to or building on an industrial site we have to take a look at it. The new construction is a 900sq ft addition to the plant for tools and storage. It is very well screened from vegetation and will most likely not be visible from Austin Rd. The plant went through all the right steps. There is no impact on lighting or parking. We will make sure the Fire Department has access. The addition will have corrugated metal siding and a sloped roof. I am recommending approval.

There was discussion about the site plan including more conversation related to the Fire Department review and the overall project plan.

Milkey- I do not believe the applicant is on the meeting call. Carl and I met with the construction manager. To be clear, there is already a building there that is just a little smaller than the new proposed one. They are going to remove the small building and rebuild. This will add very little square footage.

Enos requested Milkey to get the plan to the Fire Department for approval.

## I. Report of Chairperson

Walter-We had an inquiry about an individual running a business that deals with automotive accessories. They are looking to formalize their business in a pole barn or similar structure. The business is located on Logan Rd. just east of M52. They are looking into rezoning or getting a variance. They were instructed to start the process by putting in an application so we could start considering the site plan. They are already selling products, but they want to make sure they are being a good community partner. At this time it is just in the discussion stages.

The commissioners inquired about the nature of the business.

Milkey- This property is the old Corey Schmidt property. The individual is interested in putting aftermarket parts on primarily trucks. Things like lift kits, tires, and brush guards. They will also like to branch into the side x side market installing the same types of accessories. A large pole barn is used currently and that is what is planned for the future us. There will not be any manufacturing performed on the site. The parts are purchased from suppliers. The owner lives on the site and this will be a home-based business. He really wants to do the right thing and be a good community partner. I am glad to see someone is taking a proactive approach instead of having it addressed at a later date.
