I. Thorn Lake Solar Update

Walter- I have not heard anything since we got the DRAFT site plan.

# II. Short Term Rentals

Walter- Is there anything we need to re-address within our language?

Enos- I am recommending that we wait until legislation is passed, or not passed, before we make changes.

Milkey- I received an Email saying that Arizona just passed a bill, that is very similar to the Michigan bill, that takes short term rental power away from local control. Also, one of my biggest concerns is that short term rentals can take business away from long term rentals by offering rates that benefit the homeowner more.

#### G. NEW BUSINESS

Kolon- Is there anything that we need to do with the addressing and road naming ordinance?

Enos- I think that is a board concern, not a planning commission concern.
