#### **CLOSED SESSION:**

Motion DeRossett, seconded Carey to go into closed session to discuss the written confidential written legal opinion from our Township attorney on the current AshKay Island litigation and the short-term rental uses occurring on the same property pursuant to MCL 15.268(h) at 7:50 p.m. Ayes: Seefeld, Fusilier, Proctor, DeRossett, Carey, Moutinho, Milkey. **CARRIED.** 

Motion Milkey, Seconded Moutinho to return to open session at 8:07 p.m. Ayes: Milkey, Moutinho, Carey, DeRossett, Proctor, Fusilier, Seefeld. **CARRIED.** 

#### **OTHER BUSINESS:**

- a) Short Term Rentals. The Board unanimously approved enforcement of the ordinance violations at AshKay Island on October 10, 2017. On May 8, 2018, the decision to pursue enforcement again came before the Board, but this time resulted in a 3-3 tie. This split vote only meant that no further action was to be taken and did not overturn the Township's previous decision to enforce the AshKay Island violations. Motion DeRossett, seconded Seefeld, to affirm the Township's prior decision to commence enforcement proceedings against AshKay Island by: 1) Filing a lawsuit in Circuit Court for the zoning and building code violations on AshKay Island, including the operation of a short-term rental; and 2) Joining the current litigation against AshKay Island in the Court of Appeals as recommended by the Township attorneys. Ayes: DeRossett, Carey, Moutinho, Milkey, Seefeld, Fusilier, Proctor. CARRIED.
- b) Building Repair Update. Milkey gave an update on what is left to be done on the building repairs from the damage done on May 10, 2020. Should have everything done by the first of October.
- c) Oak Grove Cemetery. Proctor gave an update on the progress of the change of ownership for Oak Grove Cemetery. Township attorney is working on Perpetual Care Fund transfer with Old National Bank. Once that is done will forward information to the state.
- d) Village of Manchester. Milkey spoke and said we need to make sure we have open communication with the Village.
