D. PUBLIC COMMENT

Mike Brown He does not believe this project fits with the township master plan regarding preservation of rural character. Karen Revill commented on solar farm effets on property values and how the Township plans to limit solar farms in the future. Travis Fusilier also made comment on creating a moratorium to help plan and prevent future solar farm projects. Jeremy Rippley, Sabrina Blair and several other community members all had property value concerns.

Survey to propose mileage to buy property to preserve it in the township was discussed by commissioners.
